### **OPENING**

- A. Call to Order Ginny Cosbey called the meeting and public hearing to order @ 5:07pm.
- Pledge of Allegiance All in attendance stood to recite the Pledge of Allegiance.
- Adoption of the Agenda Ginny Cosbey Motioned to adopt the agenda, Megan Thomas 2<sup>nd</sup>, motion carried 3/0
- B. Public Hearing regarding the proposed Instructional Time Model for FY 2021/22 Mary Faley explained what an Instructional Time Model (ITM) is and its purpose. The Board had reviewed the ITM. Mary Faley stated this would be for students who have been placed on quarantine due to possible exposure to COVID-19, so they may continue schoolwork in a distanced learning situation. If a student is ill the preference is that the student rest. This would not be used if a student is out of town on vacation or for any other reason, strictly so students placed on quarantine can still get their assignments done and be counted present for attendance.

#### INFORMATION ITEMS

 SUPERINTENDENT'S REPORT – Mary Faley stated there have been 4 COVID -19 positive student cases since the beginning of the year. We have gone from 3' distancing back to 6'. Mary Faley has spoken to our epidemiologist about whether or not this could be spreading in the school. The epidemiologist stated since the children are all in different grade levels an these occurred at different times, it is not thought to be spreading in the school but exposures are from outside sources.

Mary Faley presented a letter from Annette Koweek in regards to masks. Annette felt it to be her obligation to reach out to families encouraging masks be worn in doors. The Board reviewed the letter. Harry Dotson asked if this would apply to staff as well. Mary Faley stated yes, masks are optional but Annette is recommending all to wear masks indoors. Anthony Fennell stated has 2 comments, 1. With 4 positive cases with my daughter being in one of the classes sitting next to child who had tested positive and did not get sick. I'm not all that concerned. Megan Thomas stated the same. 2: stated appreciates Annette's expertise and knowledge, however fells the letter need to be very clear that this is the nurse's recommendation not of the school or the Board. All Board members agree. Mary Faley stated that is a very good point and will talk to Annette to adapt the wording of the letter to be the recommendation of the nurse only. We will be flexible as we learn more to come about the current health department and CDC guidelines. Mary Faley stated she works very closely with Annette, the epidemiologist and the local health department and will continue to do so going forward so we can stay up to date with current and new information. All Board members agree.
